An easy to use visual tool

The more reports made, the lower the number of accidents

The **Heinrich pyramid** is the visual tool that allows you to **check the progress of activities to improve safety conditions at a glance.**

The assumption is that the higher the base, the lower the summit, or the more reports of behaviors and unsafe conditions they can produce, the lower the number of accidents of any kind that will actually happen.





Track and analyze each accident

How do you prevent an accident from happening again?

The only way is to understand the causes and eliminate them permanently. And it must be done not only for the accidents that have had consequences, but also for those that have not had them, the so-called "first aid", and for those that have not occurred, but were about to happen, called "near miss".

The **Exagogica solution allows you to manage the most complex studies with extraordinary simplicity**, using the 5W + 1H, Ishikawa diagram, 5 Whys methodologies. The conclusion of the analysis flow is directly connected to the identification of countermeasures and to the planning of their implementation.

A real-time collection system

***Unsafe Acts & Conditions** are the behaviors and conditions that can cause danger to health. Their reporting, together with that of the analogues for the environment, constitutes an extraordinary knowledge base for actively modifying the work environment so that it becomes increasingly safer for both operators and the environment itself.*

The Exagogica solution makes it possible to make these **reports simple and immediate** for any operator, who can do them via a mobile device, such as a smartphone, or via a touch screen terminal located near his workstation.

The reports are managed by the production managers, who define the countermeasures that must be implemented. The Prevention and Protection Service Manager receives all this information in real time and can easily monitor and control the entire reaction process to the conditions and behaviors that constitute a security risk.


Manage the **countermeasures**

Prompt and quick verification of the countermeasures to be adopted

Defining countermeasures following an accident or a report does not help much, if you are not able to quickly verify if the countermeasure has been applied and with what results.

The **Countermeasures management** function of the Exagogica solution allows the managers of the Prevention and Protection Service to verify at a glance which countermeasures still have to be implemented and to whom they have been assigned.
