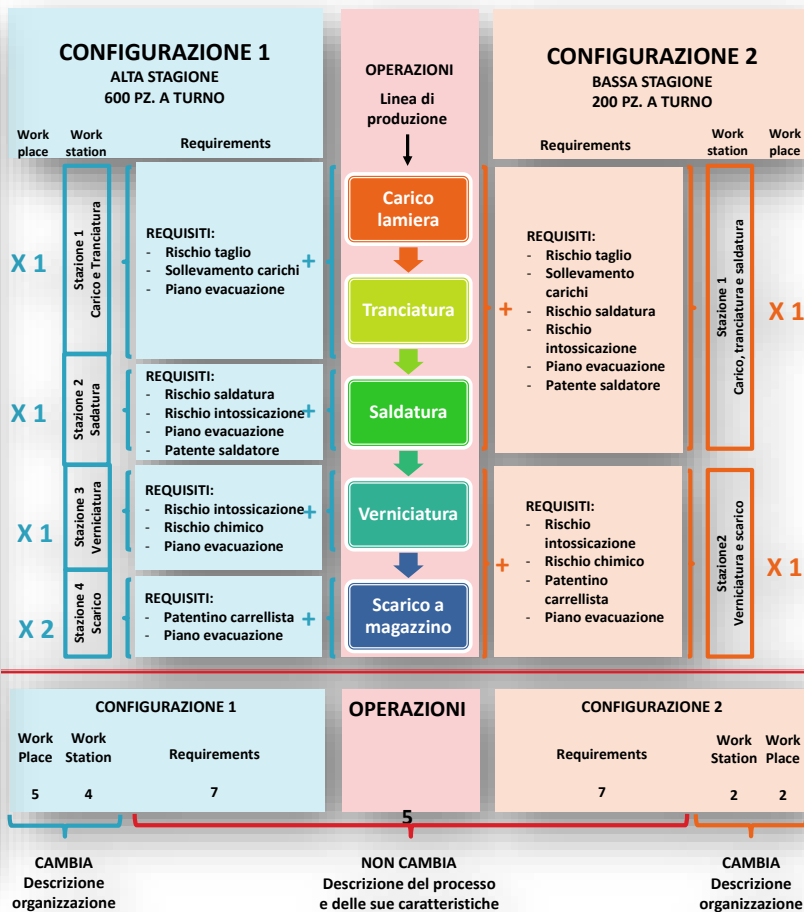


A simple and immediate tool

Different configurations with a single mapping

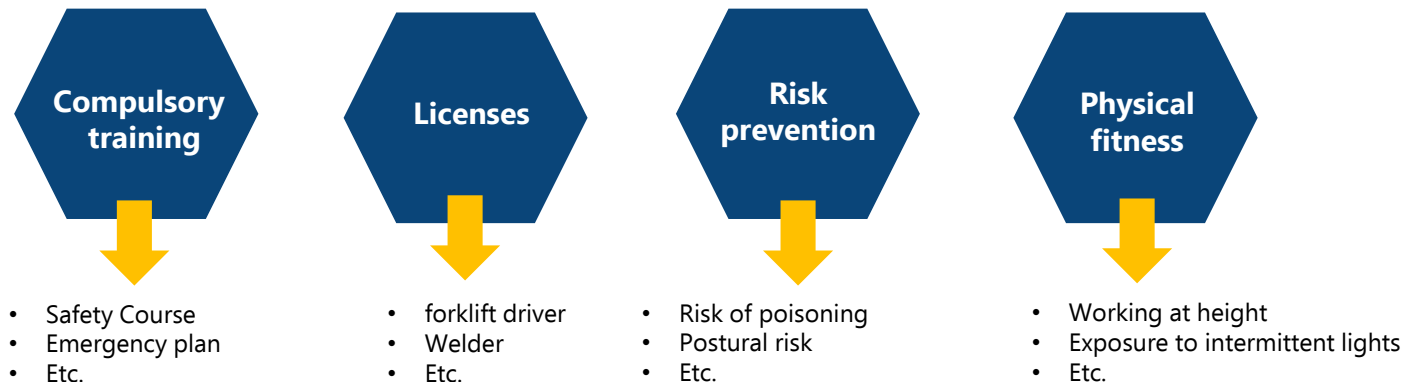
Simple and safe risk management

Operational training

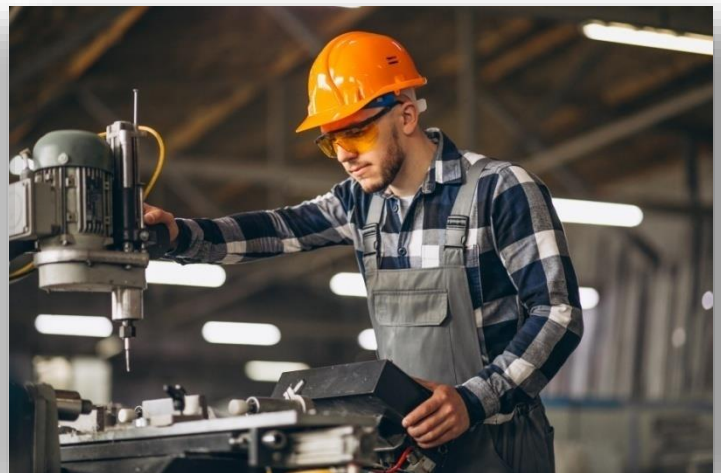
A multi-purpose and specialized team

Operator Readiness provides **simple and effective visual tools to manage the correct assignment of operators to workstations.**

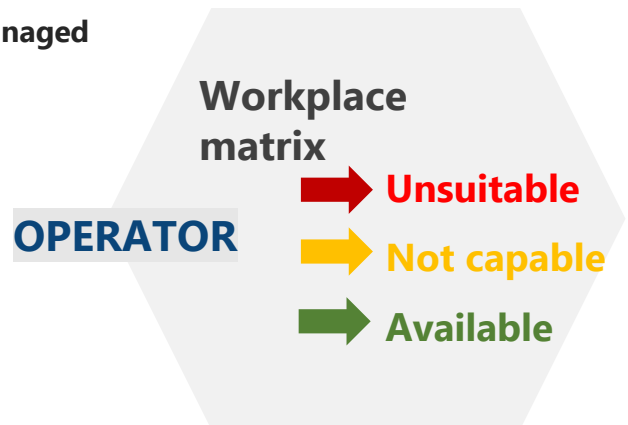
